Event Eligibility	This event is open to current ENT members (with the exception of the Supporter Category) and Alice Springs Pony Club members.  If not a member of either organisation you can purchase day membership.	
Event Information	Riders are able to enter no more than 3 classes per day, noting that 1 x Combined Training class is a total of 1 Dressage test AND 1 Jumping class each day. If you choose to ride a Combined Training class, you cannot then enter that level Dressage test or that level Jumping class as a stand alone class.	
Event Conditions	Dressage Tests may be called.

#### COMBINED TRAINING IMPORTANT INFORMATION

If you enter 2 x CT classes that have either the same Dressage test, or the same Jumping height you will only do that test/height once. Example: If you enter CT P50 and CT N50 – you will only ride the 50cm jumping round once, and your score will count for both the P50 and the N50.

## HOW DOES COMBINED TRAINING WORK

Combined Training (CT) is derived from Eventing, but it excludes the cross country phase. Horse & Rider combinations are scored on penalties in the Dressage phase, and this is then added to any penalties from the corresponding Jumping phase. The combination with the lowest penalties is the winner. The Jumping phase is a 1 round class, based on optimal time. Penalties are given for riders who exceed the time allowed (at the rate of 0.4 penalty for every commenced second). The Jumping phase is conducted under Table A, and all other usual Jumping rules apply. All Jumping classes will be run under the optimal time provisions, the same as the CT classes. If a rider is competing in a straight Jumping class (ie: not as part of a CT class), they will be scored as an optimal time class, as per the above mentioned penalty system.
