#### **CAMPING AND FACILITIES AVAILABILITY**

Camping facilities, bathroom/toilets and stables will be available to competitors for the event. Competitors need to pre-book camping sites. Stables will not be allocated to competitors prior to or during the event. It will be the competitor's responsibility to secure their own stable, keep it clean during event and when vacating the stable. Being close to the Royal Darwin Show the shade roof tops will be up.



Please note there are plenty of stable at the Show Grounds and we do not envisage any competitor will be left without a stable.

# **ACCESS TO GROUNDS**

Access for all vehicles/floats/trucks/competitors to Darwin Show Grounds is via the Hook Road entrance.

# **ACCESS TO MAIN ARENA**

The main arena will be closed from 5pm Thursday 7 July 2022 for event set up. This includes leading/lunging your horse on the arena. Only riders competing on the given day can access the main arena with their horses.

# **CATERING**

# **PRIZES**

All prizes must be collected on the day, if they are not collected, the prize will be forfeited. Please refer to the individual event schedules for prizes for each section.

# **APPROVED SAFETY HELMETS**

Riders must wear an approved safety helmet with the chin strap fastened at all times, as approved by Equestrian Australia's applicable standards for helmets at all times when mounted. Riders without approved headgear will be ineligible to compete. # **GEAR, SADDLERY AND EQUIPMENT**

All gear, saddlery and equipment must comply with Equestrian Australia's applicable standards and rules.

# **IDENTIFICATION NUMBERS**

# **ANIMAL WELFARE**

Horse welfare is paramount. Prior, during and after the event you have the sole responsibility for the welfare of your horse. This includes feeding, watering and maintenance of stable.

# **SWABBING**

The random swabbing of horses can occur at any time during an EA/ENT event. Be prepared to produce your EA Horse Registration papers to confirm the identification of your horse. # **COVID SAFETY PLAN**

in accordance with NT Government requirements, we have a COVID-19 Safety Plan.

When attending our event please observe the following key principles:

#### **PHYSICAL DISTANCING**

Abide by physical distancing rules and keep a 1.5 metre distance from people, who are not known to you.

#### **HYGIENE**

Practice good hygiene, including regular hand washing, covering a sneeze or cough with your elbow or a tissue. Avoid physical contacts such as high fives, handshakes, huddles, hugs and kisses.

If you have flu-like symptoms, please stay home. If you present to an activity with flu-like symptoms you may be asked to leave.

Neither Equestrian NT, nor the Organising Committees of their appointed officials accept any liability for any accident, theft or illness to horses, riders, grooms or any person or property whatsoever.
